About this role:

Reporting to the Vice Principal, the Head of Department is responsible for developing and leading an exciting curriculum which enables the highest level of pupil progress and attainment. The role involves managing the team of English teachers to ensure high attainment and to develop a love of learning in all pupils. The Head of English will be a member of an outstanding Academy Leadership Team, making a significant contribution to the quality of learning and teaching across the academy, supporting our school improvement.

Key responsibilities

The full remit of the post will be negotiated dependent on the skills and experience of the candidate appointed. Specific responsibilities are subject to change.

The Subject Leader will take responsibility for the following specific roles within their wider role as a middle leader of the school:

- Coordinate English across the academy.
- Lead the team of English teachers.
- Plan, resource and teach English lessons and sequences of lessons to the highest standard that ensure real learning takes place and pupils make excellent progress.
- Provide a nurturing classroom and academy environment that helps pupils to develop as learners.
- Help to maintain discipline across the whole academy.
- Contribute to the effective working of the academy.

Academy Culture

- To support the academy's values and ethos by contributing to the development and implementation of policies, practices, and procedures
- To help create a strong academy community, characterised by consistent, orderly behaviour and caring, respectful relationships.
- To help develop a school/department culture and ethos that is utterly committed to achievement and good discipline.

- To support and work in collaboration with colleagues and other professionals in and beyond the school, covering lessons and providing other support as required.
