The Role

- To work with students, parents, school staff and outside agencies to ensure the attendance and progress of students in the Alternative Provision Programme.
- To address barriers to learning for a targeted group of individual students in order to enable them to achieve their full potential
- To accelerate student learning in the provision and in the mainstream curriculum.
- To create and signpost support for families and carers of students

Key Responsibilities

All aspects of the day-to-day smooth running of the Alternative Provision Programme to include:

- Being a Key Worker for individual students and their families/carers.
- Supporting the Alternative Provision Manager and Pastoral Team in securing excellent attendance and improved self-management of the students.
- Engage parents/carers of students so that they have active involvement in the required improvements, whilst supporting them with parenting workshops.
- Implement and sustain regular parent and student meetings as part of the monitoring of the student's progress.
- maintain accurate recording of all communications with parents, agencies and any other parties.
- Ensure the consistent implementation of the Behaviour for Learning Policy
- Sustain high visibility and availability in and around the school in order to proactively identify and address any inappropriate behaviours
- Create and initiate new ideas when dealing with targeting individuals or groups
- Record, monitor and track students' behaviour and use this information to inform actions
- As required, working with individual children or groups inside or outside the classroom
- To work alongside the Safeguarding Team to implement safeguarding and the Academy Child Protection procedures
- Seek out local agencies and support networks to build effective partnerships with the school and the parents.

Duties

- Carry out home visits to support families/children, and help to access other services, referring where appropriate
- Communicate regularly with families, academy staff and other agencies ensuring that follow-up work is done and all concerned are well informed
- Effectively manage the daily behaviour of vulnerable students in order to prevent exclusion and disaffection from mainstream provision within the Alternative Provision Programme
- Lead learning and group activities within the Alternative Provision Programme as required
- Lead key working with individual students within the Alternative Provision Programme
- Work in partnership with parents/carers to increase their confidence and resilience to encourage positive family relationships and promote children's development and the health and wellbeing of all family members
- Attend and contribute to Pastoral Support Plan Meetings and Team around the Child meetings as appropriate
- Support the transition and reintegration (where appropriate) for all students within the Alternative Provision Programme

- Actively promote the safety and welfare of our children and young people
- Ensure compliance with Ark's data protection rules and procedures

- Support other school duties, invigilation and enrichment.
