

Job Description: School Counsellor and Mental Health Lead

At ARK Kings Academy we take safeguarding very seriously. All adults who regularly work on our site are required to undergo a Disclosure and Barring Service (DBS) check to prevent unsuitable people from working with students.

The Role

You will provide counselling support and programmes to support students' well-being across the academy and work in consultation with academy staff including teachers, parents and carers to support and enhance support offers to students.

You will be the main point of contact for staff seeking wellbeing advice and will support the senior leadership team in their focus on staff mental health and wellbeing.

Key Responsibilities

- Provide a high-quality counselling service to students experiencing a wide range of emotional problems
- Provide support, guidance and advice to parents, carers and the colleagues where required
- Contribute to the safeguarding and promotion of the welfare and personal care of children and young people
- Establish an effective screening and assessment process to set baselines, and to implement a tracking/monitoring system for your caseload
- Observe confidentiality and to maintain confidential files including relevant care plans
- Liaise with our Health & Welfare Assistant and relevant external agencies
- Review and develop policies and programmes related to the mental health of young people
- Liaise with the Welfare Lead and the senior leadership team to respond to students' needs as identified by teachers, parents, staff and students themselves to ensure approaches are individualised
- Run issue- based workshops e.g. anger management, resilience building, self-esteem, social skills and stress management
- Provide 1:1 short-term counselling to students who need support in times of family loss, illness, stress and friendship issues
- Provide a series of time-limited 1:1 counselling sessions for students with ongoing mental health issues
- Contribute to/take responsibility for writing letters/referrals for students with more complex needs in order to draw in additional support from relevant external agencies

- Support the improvement of attendance, behaviour, health and wellbeing of students and staff
- To undergo first aid training and to provide in school first aid where required

Other

- Actively promote the safety and welfare of our children and young people
- Ensure compliance with Ark's data protection rules and procedures
- Liaise with colleagues and external contacts at all levels of seniority with confidence, tact and diplomacy
- Work with Ark Central and other academies in the Ark network, to establish good practice throughout the network, offering support where required

- Minimum of 2 year's post qualification experience
- Minimum of 1 years' experience of working with children and young people

- Belief that every student should have access to an excellent education regardless of background

- Understanding of the importance of confidentiality and discretion
- Flexible attitude towards work and demonstrates sound judgement
